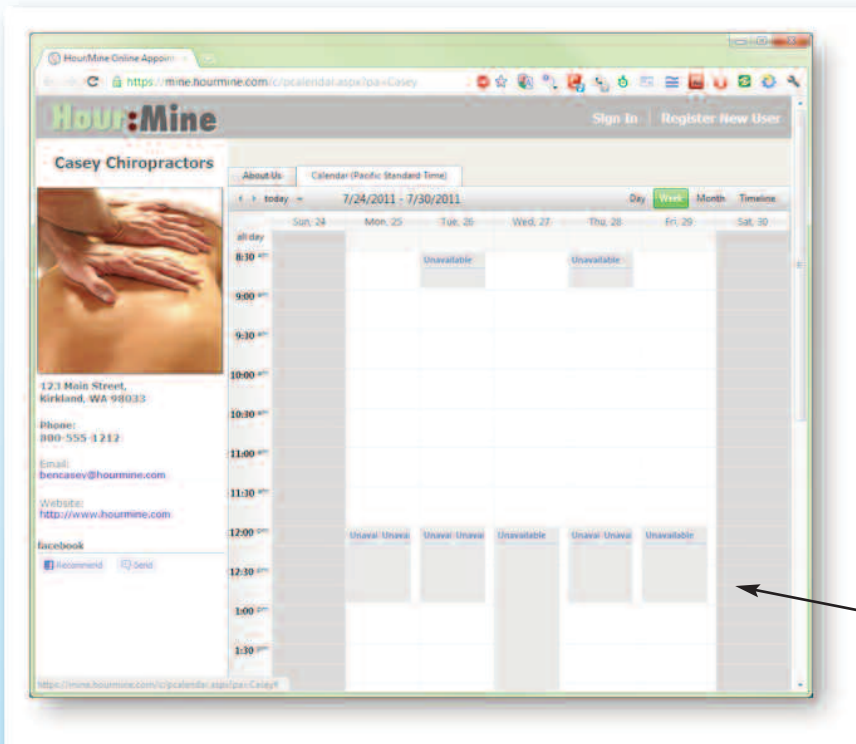

**ECLIPSE is now ONC-ATCB certified as a Complete EHR by CCHIT for all “Meaningful Use” measures.** Visit <https://ehrincentives.cms.gov/hitech/login.action> to register for Meaningful Use *before* October 1st to qualify for incentive payments. Our registration # is **CC-1112-353010-3**.

Note that many consultants & seminars are providing erroneous information regarding what you need to do to qualify for Meaningful Use. These presentations often fail to differentiate between what your certified technology needs to be capable of vs. what you need to actually do within your practice. (More specifically, they mistake core & menu set objectives with reporting requirements -- creating the impression you need to do more than is actually required.) Download an update and review the README for complete instructions with regard to reporting requirements. Visit the CMS website for further documentation.

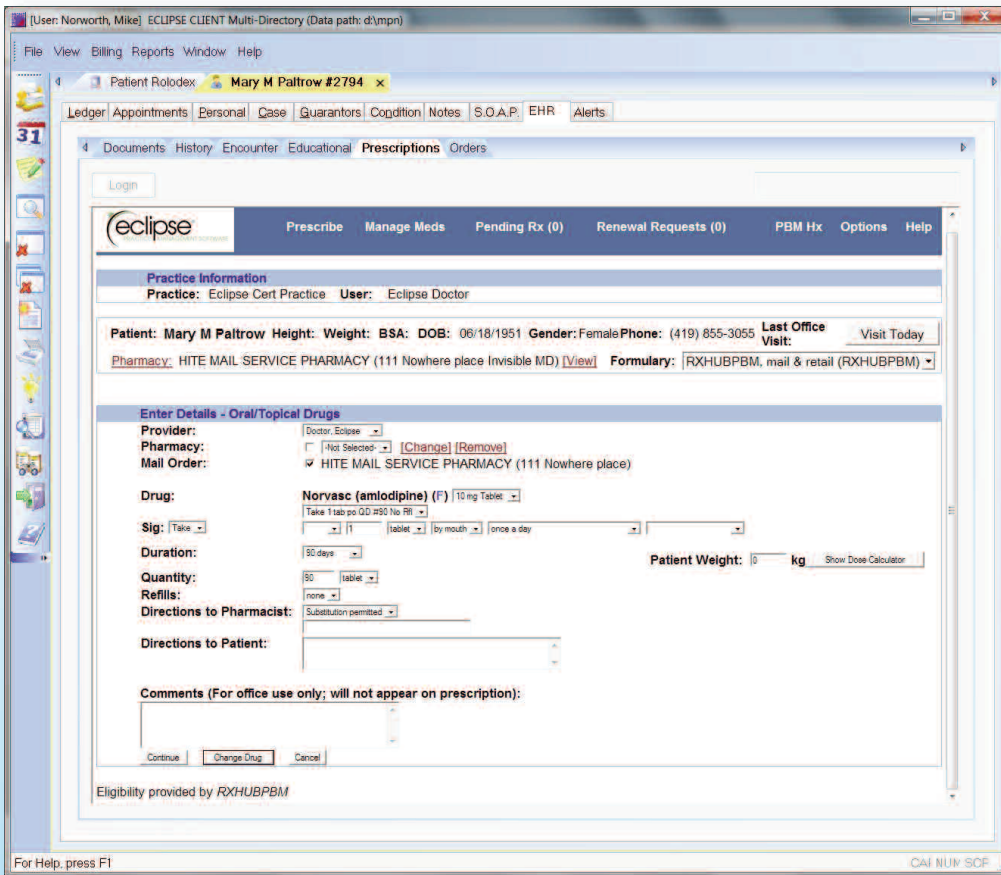
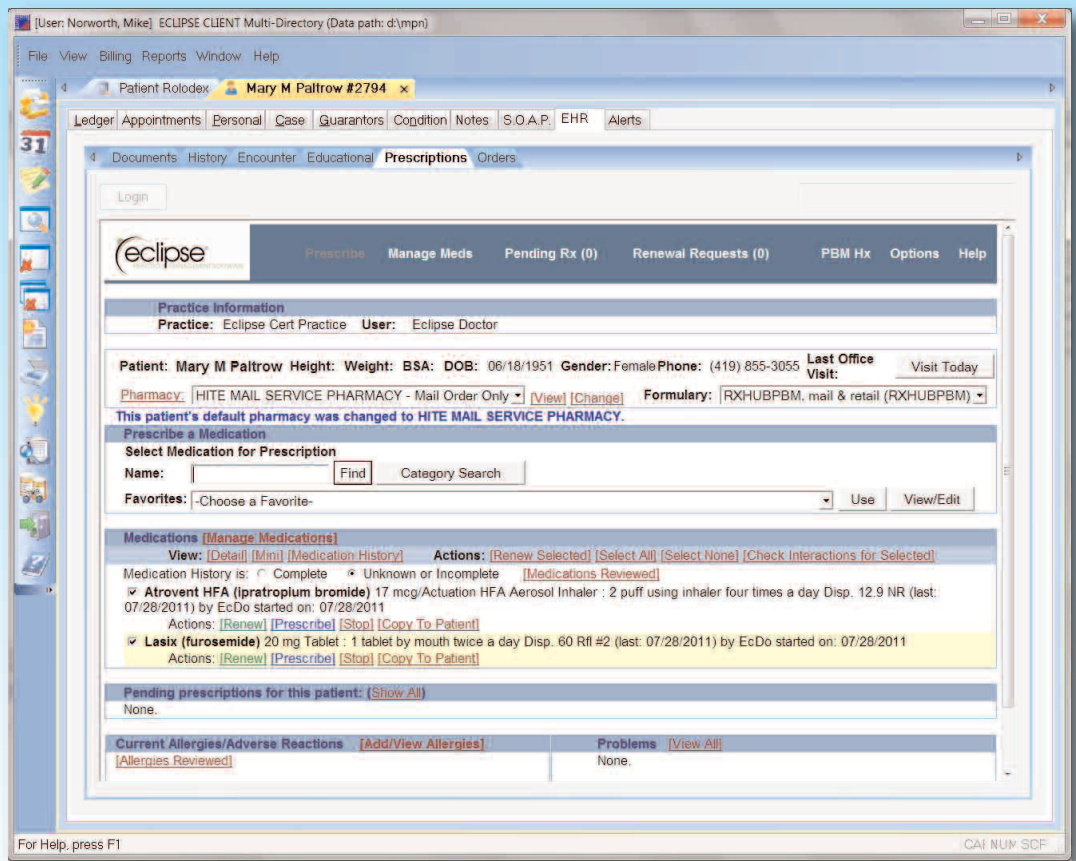
